Chapter 2256.023, Government Code (The Public Funds Investment Act), requires the investment officer of each local government to submit to its governing body a quarterly report of investment transactions.

The attached report details investments for Victoria County, Citizens Medical Center and Victoria County Navigation District for the quarter ending December 31, 2022.

Portfolios total \$103,656,489.57, invested with an emphasis on safety, liquidity and yield. The portfolio for the quarter is; LOGIC Pool 2.04%, Certificate of Deposits 10.35% and 87.61% in cash with an average interest rate of 2.21%.

Investment cash accounts at Prosperity Bank earned an average .40% for the quarter

Federal Reserve Bank Fed Fund interest rate increased 1.50% this quarter and the forecast is predicting more possibly rate hikes through 2023 to a predicted rate of 5.1%. Currently the Fed Funds interest rate is 4.25% to 4.50%.

Pledged collateral of bank deposits, held by Prosperity Bank, is above limits required by our depository contract.

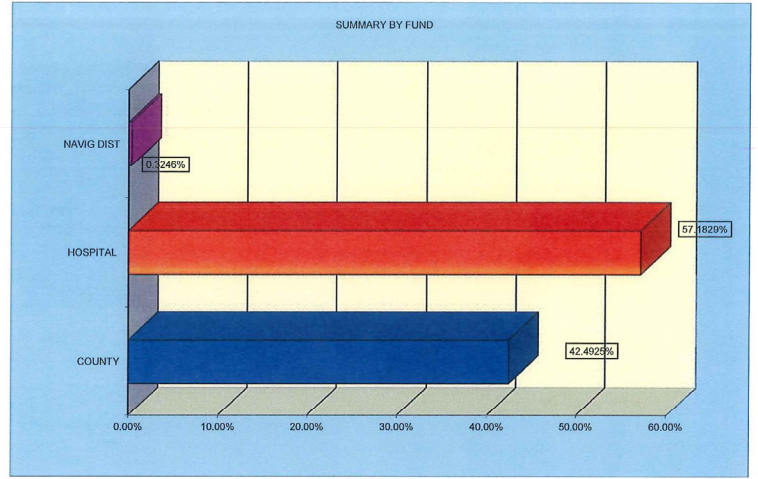
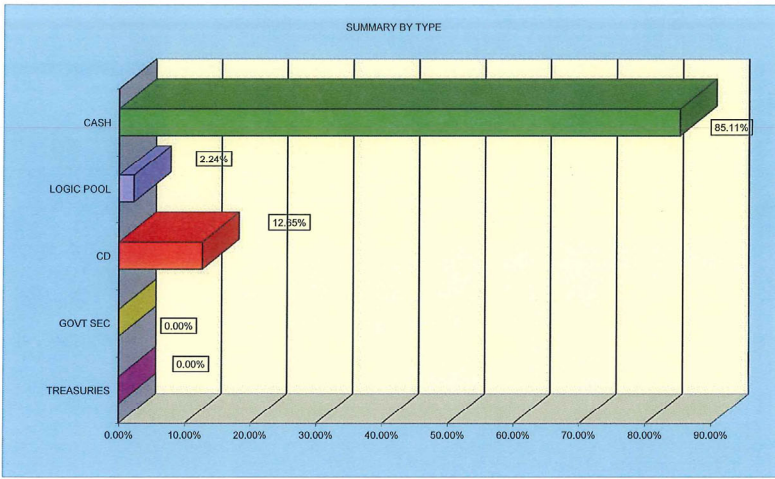
