Chapter 2256.023, Government Code (The Public Funds Investment Act), requires the investment officer of each local government to submit to its governing body a quarterly report of investment transactions.

The attached report details investments for Victoria County, Citizens Medical Center and Victoria County Navigation District for the quarter ending March 31, 2020.

Portfolios total \$104,759,779.59 and are invested with an emphasis on safety, liquidity and yield. The portfolio for the quarter was invested in LOGIC Pool 5.02%, Certificate of Deposits 12.32% and 82.66% in cash with an average interest rate of 1.795%.

Federal Reserve Bank reduced the Fed Fund interest rate two times this quarter. Investment cash accounts at Prosperity Bank earned an average 1.6% for the quarter.

Pledged collateral of bank deposits held by Prosperity Bank is monitored and is above limits required by our depository contract.

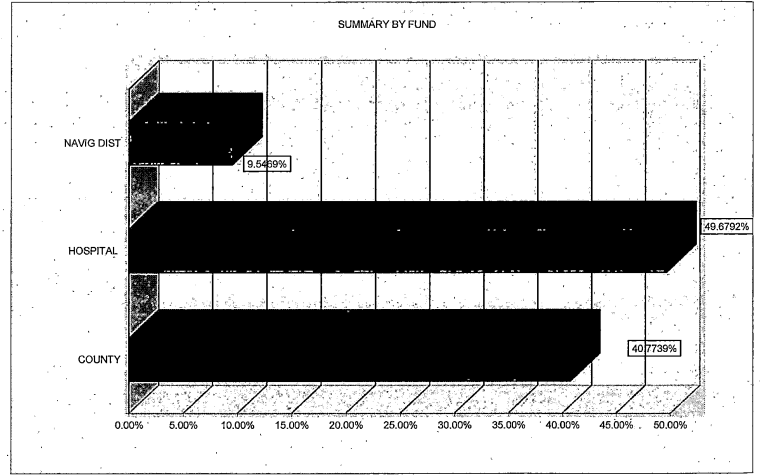
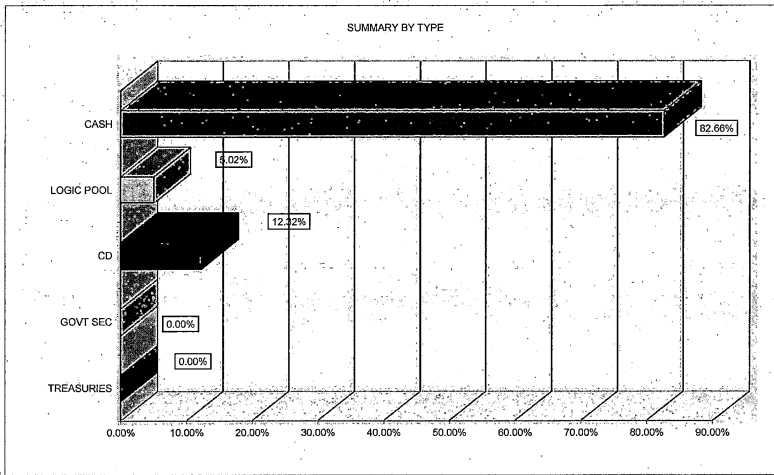
